

The Monroe County Board of Supervisors met pursuant to adjournment on February 27, 2018, with Board of Supervisor members John Hughes (Chairman), Dennis Amoss and Michael R. Beary present.

Minutes of February 20, 2018, read and signed for approval by Board of Supervisors.

Motion by Beary and seconded by Amoss to approve the completion on the jail demo by Lathrop Farms. Final demo and utility removal costs came in at \$28,087.50.

All voting aye. Motion carried.

Motion by Amoss and seconded by Beary to approve a warranty deed transferring the former jail lot to City of Albia, legally described as follows:

*Lots 7 and 8 in Block 4 in the Second Survey of the City of Albia, Iowa. The east one-half of the alley lying between Lots 6 and 7 in block 4 of the Second Survey of the City of Albia, Monroe County, Iowa.*

All voting aye. Motion carried.

Motion by Amoss and seconded by Beary to approve County Farm Lease with Randy Denburger for 2018-2021 in the amount of \$34,500 annually.

All voting aye. Motion carried.

Chairman opened the public hearing on the proposed Monroe County Budget for Fiscal year 2018/2019 at 10 am. Notice was published in both official newspapers on February 13th and February 15th.

Persons present were Deputy Auditor Chris Turner, Albia Newspaper representative Dave Paxton; Recorder Tracy Casady, Engineer Jeremiah Selby; CPC Katie Fisher; Veteran Affairs Carrie Gray; County Attorney John Pabst.

There were no oral or written objections filed.

Motion by Beary and seconded by Amoss to close the public hearing at 10:03 a.m.
