

The Monroe County Board of Supervisors met pursuant to adjournment on September 25, 2018, with Board of Supervisor members John Hughes (Chairman), Dennis Amoss, and Michael R. Beary present.

Minutes of September 18, 2018, read and signed for approval by Board of Supervisors.

Motion by Amoss and seconded by Beary to support the complaint and affidavit (no. agin 062818) barring defendant Ryan M Harris from entering the Monroe County Court House unless accompanied by a law enforcement officer as well as the order from Judge Kirk Daily that the defendant shall have no contact with the clerk's office nor shall he be in the court house except for court appearances in which case the clerk's office will request law enforcement presence.

Motion by Beary and seconded by Amoss to accept Interim Zoning Administrator Randy Noe's letter of resignation.

All voting aye. Motion carried.

Motion by Amoss seconded by Beary to request County Attorney John Pabst look into the process of repealing zoning in Monroe County. Beary stated that his second did not mean he offered his seal of approval to repeal zoning.

All voting aye. Motion carried.

Chariton Valley Planning and Development's Nichole Moore recommended that the county speak with County Attorney Pabst to see if her organization could act as interim zoning administrators until a more permanent solution could be found.

The Board of Supervisors examined and allowed claims – check numbers 1196-1393 included.
