Sept. 10, 2013
Absentee Voting and Voter Registration

Absentee Ballots for the Sept. 10, 2013 School Election are available in the Monroe County Auditor's Office. Voters wishing to vote absentee in the **Albia Community School District** may do so in person in the Monroe County Auditor's Office Monday through Friday, 8:00 a.m. to 4:00 p.m. **or** voters may request an absentee ballot be mailed to their residence.

Monroe County residents who live in the **Eddyville-Blakesburg-Fremont School District** should contact Wapello County Auditor's Office to request a ballot for Eddyville-Blakesburg-Fremont School Election. Ph. 641-641-683-0020 Wapello Co. Auditor – 101 W 4th St – Ottumwa, IA 52501

Monroe County residents who live in the **Moravia School District** should contact the Appanoose County Auditor's Office to request a ballot for the Moravia School Election. Ph. 641-856-6191 Appanoose Co. Auditor – 201 N 12th – Centerville, IA 52544

You may also send a handwritten request with the following information:

Voters Name, IA Driver's License Number; IA Non-operator ID Number or last 4 digits of Social Security Number, Birthdate, Registered Address, Mailing Address (if different than registered address), Name and Date of Election. **(School Election – Sept. 10, 2013)**

The request **must be signed and dated by the voter requesting the ballot**. Mail requests or hand deliver them to the office of: Monroe Co. Auditor, 10 Benton Ave. East, Albia, IA 52531.

- **Deadline to request Absentee Ballot by mail is Fri., Sept. 6, 2013– 5:00 p.m.**
 - **Absentee Ballots must be postmarked no later than Sept. 9, 2013 and received before the Canvass on Sept. 13, 2013**
 - **Deadline to vote Absentee in- person is Tuesday, Sept. 10, 2013 – 11:00 a.m. for Albia Community Schools**

Voter pre-registration deadlines for the School Election are:

- **Friday, Aug. 30, 2013 - 5:00 p.m.**
- **Registration forms which are postmarked on or before August 26, 2013** are considered on time for the School Election, even if they are received after 5 p.m. on Aug. 30, 2013.
