

The Monroe County Board of Supervisors met pursuant to adjournment July 14, 2020 with Board of Supervisor members John Hughes (Chairman), Dennis Amoss (Vice-Chairman) and Michael R. Beary present.

Minutes of June 30, 2020, read and signed for approval by Board of Supervisors.

Motion by Beary and seconded by Amoss to table discussion of a request from Albia Chamber of Commerce to sell alcohol on the courthouse lawn and associated liquor permits.

All voting aye. Motion carried.

Motion by Amoss and seconded by Beary to approve utility permit applications for Windstream Iowa Communications, LLC in Sections 1 & 12 of Guilford Township.

All voting aye. Motion carried.

Motion by Amoss and seconded by Beary to approve hiring Amy Keegel as Zoning Director, effective immediately. The position is part-time, not to exceed 28 hours per week, and the salary is \$15,000 annually.

All voting aye. Motion carried.

County Attorney John Pabst was present to discuss HF 2590 relating to firearms and weapons. Pabst said the county currently has no known policy on firearms, and the order from Judge Cady of the Iowa Supreme Court still stands. He recommends no change to the county signage until further information is known. No action taken.

At 9:50 am Chairman Hughes opened the canvass of votes cast at the Special Election for the City of Albia held on July 7, 2020.

Amanda R. Harlan, Monroe County Auditor and Commissioner of Elections, announced there were no provisional ballots cast and no absentee ballots rejected by the Absentee Board for reasons per the Iowa Code.

Auditor Harlan read the combined canvass summary for the Special Election as Supervisors verified those figures to the tally book tapes, Abstract, Tally Book Summary Report and Precinct Detail Report.

Motion by Beary and seconded by Amoss to declare the canvass complete and certify the results of the election to the County Commissioner of Elections and the city of Albia. Final results are on file for public review in the Monroe County Auditor's Office or online at <http://www.monroecoia.us/electionarchive.htm> .

All voting aye. Motion carried.

The following person is declared duly elected: Albia City Council Member At Large to fill a vacancy, Leslie Hill.

Canvass concluded at 10 am.
